NOTICE OF RACE

1. Organization

The Yacht Club de Cavalaire, under the sponsorship of the Fédération Française de Voile, in accordance with the Association de Classe 29er organizes the Eurocup, french stage from April 11th to 13th 2009.

2. Applicable rules .

- the rules as defined in the ISAF RRS 2009-2012,
 - the FFVoile's prescriptions,
 - the current class rules,
 - this notice of race,
 - the Sailing instructions and appendix.
- Advertising : the event is classified category C in accordance to the ISAF regulation 20 – advertising code.

3. Eligibility/Entry

The event is open to the 29er class. Each competitor shall comply with its National Authority rules (national sailing license, medical authorization for sailing in competition, special authorization from parent or coach for underage competitor will be required and be up to date with its international contribution.

With confirmation of its entry, each competitor shall confirm that it is its own responsibility, in any condition, to decide to start and to continue a race.

4. Responsibility and insurance.

In any case the organizing committee will have responsibility of loose, damage or accident which could be taken place during the event.

The license delivered by the FFVoile to French competitor covers these particular problems.

However any support person and coaches shall have third party insurance that covers damages at the same level of the FFVoile license.

The competitors, coaches and accompanying people coming from other countries shall provide on the registration office, an evidence of a third party insurance, with a minimum coverage of 1.500.000€ or the equivalent in other currencies, which covers any damage or accident caused at any time of the event.

5. Schedule

6. Event format.

Depending on the number of entered boats, it may be set up a qualifying series phase and a final serie phase (gold and silver fleets). In case of qualifying series phase, 4 validated races are required for any transition to the final phase. Qualifying series will contain about an equal number of boats. The gold fleet will be limited to the first 25 boats.

7. Courses

The format of the course will be an up/down wind race.

8. Penalties

8.1. The ISAF Regulation 44.2, rotation 1 lap will be applied.

9. Scoring

- The low point scoring system of ISAF Regulation appendix 4.1 shall apply.
- 4 races are required for the event validation.

10. Sailing instructions

Sailing Instructions will be available at the race office until the registration closure deadline (art.5 Notice of race).

11. Measurement control

Each boat shall comply with the current Class Rules. Measurement Control could be organized during the event either ashore or onshore.

12. Incriptions

Registration fees are to be paid at the Yacht club of Cavalaire order

- ◆ **130€ before March 31th 2009**
- ◆ **150€ after April 1st 2009**

**For French crews, a pre-registration without including fees payment will not be valid.
For crews coming from other countries, : they should send their registration in advance and pay up on the sum of 130 €.**

Final registration : The measurement control and the registration are scheduled on Friday 10th April from 09h00 to 18h00.

For registration validation each competitor shall produced :

- sailing license 2009 with a medical authorization to race.
- National class registration
- advertising license, if required (for French competitor only)
- authorization to participate to the event, if less than 18 years old, delivered by parent or coach (see registration form).

13. Coach registration

Coaches and accompanying persons with a boat, will return to earlier form attached , duly completed, and supporting documents required to obtain a free port. As of April 8, seats will be borne by the laggards.
